Consumption and/or use of all categories of narcotics on board **MAHODAYA**, including marijuana, will not be tolerated in any form and will be reported immediately to the relevant authorities. Any persons involved in such activities will be instructed by the Captain to leave the vessel immediately.

MAHODAYA management will not be held liable for any action taken against crew or guests by the authorities in the implementation of Government anti-drug policies, including police arrest.

Standard Terms & Conditions

- A 50% Non-refundable deposit will be required within 14 days to confirm your cruise reservation dates.
- Final and full payment (Non-refundable) for your cruise must be received 60 days prior to the stated trip date.
- In the event that your cruise plans or travel dates change, for any reason, we will:
 - Hold your reservation open and valid for a period of 24 months from the date of your full payment being received by our office, OR
 - Allow you to “replace” your cruise with a cruise of equal value to an alternative **MAHODAYA** destination within a period of 24 months subject to availability, OR
 - Refund payments already received, less any direct costs incurred in advance by the company necessary to facilitate the cruise, ONLY in the event that the company is totally unable to deliver the services paid for due to unavailability of the vessel, or due to any Indonesian or other Government mandated restriction.
- Cruise Rates are quoted in US dollars. Final billing will be processed in Indonesian Rupiah at the current rate of exchange effective the date of receipt of funds and are subject to Government Tax of 11% and Service Charge of 10%.
- Cruise Rates and Government taxes, are subject to change without notice.

Supplementary Essential Information

- All visitors to Indonesia must have at least 6 months validity on their Passport.
- Please ensure your passport has at least four (4) clear pages as required by the Indonesian Immigration Authorities.
- For assistance with “Visa On Arrival” information please contact our office staff in Jakarta.
- Indonesian commercial airlines including Garuda, Batik Air, Air Asia, Lion Air, and Citilink’s flight schedules are all available online. Our office is always happy to assist to book/reconfirm your flights on Garuda, Batik Air and/or any other commercial airlines, however we will not be held responsible for any changes/delays/cancellation of these flights. Be advised each airline has different baggage allowances. Please inform our office for any special requests.
